Dear Sir,

This is with reference to your letter no APL/T&D/12-13/PGCIL/SKLM/3895 dated 22/08/2012 requesting for approval of M/S IAC Electrical Pvt. Lt., Kolkatta for supply of 765kV Hardwares & Accessories against the subject LOA.

In this regard please note that IAC's unit –II located at Plot no.:53, Sankrail Industrial Park, NH-6, Dhaulagiri, PO-Dhaultagiri, Dist: Howrah was approved by POWERGRID in May 2012 for supply of Hardwares and accessories for Conductor and earthwire, except Spacer Damper, for supply of 400kV Transmsission line, subject to the following conditions.

- (i) The approval is initially valid for a period of one year from the date of release of the letter (which is 08/05/2012) and thereafter POWERGRID will re-assess M/S IAC Electricals for further extension.
- (ii) All raw material are to be procured from POWERGRID approved sources only
- (iii) M/S IAC will perform quarterly process audit of their sub-vendors works to ensure quality of their material and maintain it records.

Further, based on your request & assessment by POWERGRID, M/S IAC's Unit-II at Dhaultagiri is hereby approved also for supply of Hardwares and accessories for Conductor and earthwire, (except Spacer Damper) for 765kV trans. Line within the earlier approved period of one year and subject to the above conditions indicated in the earlier approval.

Further, it may be mentioned that the approval accorded herewith is technical approval and contractual aspects, if any, for the proposed supply of 765kV Hardwares & Accessories against the subject package looked into by our site / region for which you may take up the matter with them.
